# Honoring Philanthropic Excellence at the 2025 Make Your Mark Awards

The evening was filled with gratitude, inspiration, and heartfelt recognition across five award categories: Legacy, Contemporary, Professional Advisor, Business, and Nonprofit. Each honoree exemplifies of collaboration that defines our community.

### **Nonprofit Award: Salina Grace**

Salina Grace was honored for its unwavering commitment to serving Salina's homeless population. What began in 2017 as a seasonal shelter has grown into a year-round Community Resource Center, now located at 315 S. Broadway. Through partnerships with agencies like CKF Addiction Treatment and Salina Family Healthcare Center, Salina

Grace provides wraparound services including meals, showers, laundry, and crisis navigation. With over 800 individuals served annually, Salina Grace continues to be a beacon of hope and healing.

# **Donor Advised Funds:** A smart year-end giving strategy



As the year draws to a close, now is the perfect time to review your charitable giving strategy. If you want to make a bigger impact, and potentially receive greater tax benefits, a donor advised fund (DAF) at the community foundation can help you do both.

### **Bundle Two Years of Giving into One Smart Gift**

By "bunching" or bundling two years of your charitable gifts into a Donor Advised Fund (DAF) at the Community Foundation, you can surpass the standard deduction threshold and itemize your charitable giving for greater tax savings.

When you contribute to your DAF, you receive the full charitable deduction in the year of your gift, but you don't have to decide right away where your grants will go. You can distribute them over time to your favorite charities, allowing your dollars to make a lasting difference.

If you regularly itemize deductions on your income tax return, you might have heard that things are changing in 2026 when both a floor cap on itemized charitable deductions kick in. This means 2025 offers a unique opportunity to "front-load" or "bunch" charitable donations into your DAF before the tax landscape shifts.

This example compares the difference in tax savings over a 2-year period, assuming a married couple joint filing with a standard deduction of \$31,500 in 2025 and a \$32,200 standard deduction in 2026.

### **Donate Appreciated Securities or Cryptocurrency**

If you have stock or cryptocurrency that has grown in value (and you've owned for at least a year), consider donating it to a Donor Advised Fund at the Community Foundation. You'll avoid capital gains tax and receive a charitable deduction for the full market value of your asset, and can decide where to give later. You can also deduct up to 30% of your adjusted gross income for these gifts and carry the remainder of their value up to five years.

# Donor Advised Fund Powers Dual Matching Challenges

healthcare.

# Expanding Youth Services: Boys & Girls Club of Salina

A \$500,000 matching gift from the Augustine family is helping launch a long-awaited Boys & Girls Club in Salina. The gift, made through the fund at GSCF, honors the legacy of Ted and Almita Augustine and offers a dollar-for-dollar match to support both startup operations and long-term sustainability for the club.

"Our families are excited to support the start of a Salina-based Boys and Girls Club," said Donna Augustine-Shaw and Mark Augustine in a statement. "The plan is strong, the partnerships are in place, and the need in our community is real."

"This matching gift challenge is a game-changer," said Lance Patterson, CEO of the Boys & Girls Club of Hutchinson. "It helps us meet the immediate needs to open our doors in Salina, while also building the foundation to serve kids for generations to come."

The Club is expected to open by the end of 2025 at Oakdale Elementary School, with future plans for a permanent facility in the Sunset Park area. Donations made to the endowed Boys and Girls Club of Salina Fund held at GSCF by December 31, 2025, will be matched with an equal amount for immediate operational support, up to \$500,000.

# Strengthening Rural Healthcare: Salina Family Healthcare Center

The Augustine Fund has also pledged a \$1 million matching challenge to support the development of a new healthcare facility for Salina Family Healthcare Center (SFHC). Their gift will match \$1 for every \$4 raised locally, up to \$1 million, and serves as a cornerstone for SFHC's \$10 million community-focused fundraising campaign.

The new facility will expand access to integrated medical, dental, eye care, behavioral health and pharmacy services, while also supporting physician training through the Smoky Hill Family Medicine Residency Program.

"We are familiar with the need for healthcare in rural Kansas," said Mark Augustine. "Both of our parents grew up in rural Kansas, and this is a meaningful way to help Salina and our community. We are excited to have our parents' legacy honored through this new facility and by expanding access to care throughout Kansas."

### A Legacy of Impact Through GSCF

Both matching gifts are being distributed through the Ted and Almita Augustine Donor Advised Fund held at GSCF. The fund has become a powerful tool for honoring the Augustine family's values and investing in projects that reflect their commitment to education, health and opportunity.

"I can't think of a more meaningful way to carry forward Ted and Almita's legacy than through these final grants from their donor advised fund," said Jessica Maritn, President & Executive Director of GSCF.

# Post Rock Community Foundation: Barbara A. Wolford Fund



Two young farmers are expanding their cattle operations in Lincoln County thanks to a grant from the Barbara A. Wolford Fund held at the Post Rock Community Foundation.

Barbara was a lifelong bookkeeper who worked at an implement dealership in Dighton and later at several banks, including Beverly and Lincoln. Her career in bookkeeping, love for rural Kansas, and deep appreciation for the farming lifestyle inspired her to create a permanent endowed fund at the Foundation through her estate. Her vision was to help young or beginning farmers start or expand their farming operations.

"We are deeply honored and grateful to receive Barbara's extraordinary estate gift," said Elisa Agler, Director of the Post Rock Community Foundation. "Her generosity will have a lasting impact—empowering young farmers with the resources, opportunities, and support they need to thrive. In a small rural community like ours, this is more than a gift. It's a lifeline."

Through a partnership with the Lincoln County Economic Development Foundation, \$50,000 was awarded in grants to support two local operations:

- Luck Farms received \$28,750 to assist with a down payment on adjacent farmland. The expansion will allow them to nearly double their herd size, increase acreage for rotational grazing, raise and maintain a healthy cattle operation, and boost the amount of feed and grain crops they can produce.
- Wiebke Ranch received \$21,250 to purchase and install essential infrastructure, equipment, and supplies to modernize and expand their ranch. This growth will also allow them to move into directto-consumer beef sales, supply local schools and restaurants, and establish an honor-system beef stand in town.

"For us, ranching is more than a business—it's a way to build lasting relationships and contribute to the vitality of rural life," shared the Wiebke family. "We value the Post Rock Region not only for its land and resources, but for the people who make it home. Our goal is to create a sustainable operation that benefits our neighbors today and leaves a legacy for our children."
